## ONE-YEAR TAPE RECORDER WARRANTY

**AKAI** Tape Recorders (exclusive of video-tape recorders) purchased new from Authorized Dealers within the Continental Limits of the United States of America are warranted to the ORIGINAL purchaser only, to be free from defects in materials and workmanship, according to the terms and exclusions below, by **AKAI AMERICA, LTD.** Repairs which are eligible for warranty consideration as defined herein shall be performed at no charge for parts for ONE YEAR\* from date of purchase, providing that the conditions below are satisfied:

**THE PURCHASER MUST RETAIN HIS BILL OF SALE or other, documented, dated proof-of-purchase describing the merchandise to establish the validity of a warranty claim** and must submit a machine-reproduction of such proof-of-purchase document to the servicing agent at any time warranty service is solicited. **AKAI AMERICA, LTD.** shall have the discretion to DENY WARRANTY without dated proof-of-purchase. (Submission of a warranty card does NOT establish warranty protection.) Any evidence of alteration, erasure or forgery to proof-of-purchase documents shall be cause to void any and all warranty terms immediately or retroactively.

### WARRANTY EXCLUSIONS

NOT COVERED BY WARRANTY are damages which may be the result of shipping or transit, accident, abuse, misuse, operation in exception to furnished instructions, operation on incorrect power supplies, operation with faulty associated equipment, unauthorized service or tampering, modifications, alterations or normal wear and tear attributable to regular usage. **UNITS ON WHICH THE SERIAL NUMBER HAS BEEN DEFACED OR REMOVED SHALL NOT BE ELIGIBLE FOR WARRANTY CONSIDERATION!**

Warranty repairs must be performed by **AKAI AMERICA, LTD.** or its authorized agents and no warranty consideration or reimbursement for service elsewhere shall be made. (The name and address of the nearest or most suitable agent will be provided at the time of need, upon written request, as such agents are subject to change without notice.) Every effort will be made to accomplish warranty repairs within thirty days from receipt by the servicing facility except when delayed by conditions beyond the reasonable control of **AKAI AMERICA, LTD.** Should any equipment submitted for warranty repair be found ineligible for warranty protection described herein, an estimate of approximate normal repair costs will be furnished and work accomplished upon receipt of payment or other, mutually agreeable terms of payment. Should shipment of equipment be required to obtain warranty service the OWNER shall be obligated only for ONE-WAY transit costs, including adequate insurance and packing. Unauthorized collect shipments may be refused.

There is no other warranty, express or implied, which extends beyond the face hereof. No dealer, representative, agent or employee is authorized to determine or recommend the suitability, applicability or merchantability of any product for any purpose and such decision is the sole responsibility of the buyer. No dealer, representative, agent or employee except the **AKAI AMERICA, LTD.** National Service Manager is authorized to grant any exception to the terms and conditions of the warranty as stated herein. In no event shall **AKAI AMERICA, LTD.** be liable for any consequential or special damages. **AKAI AMERICA, LTD.** reserves the right to make changes in design or manufacture without incurring any obligation to install such changes upon any of its products theretofore manufactured.

- \* **AKAI** audio Tape Recorders used in commercial, industrial or professional applications shall carry a 90-DAY warranty for parts and labor costs and otherwise subject to the same conditions as stated above.
- \* Non-domestic purchases receive 90 days labor, 1 year parts coverage.
- \* "GX" Heads warranted against wear for 150,000 hours of use. (Parts—only after 1 year.)
